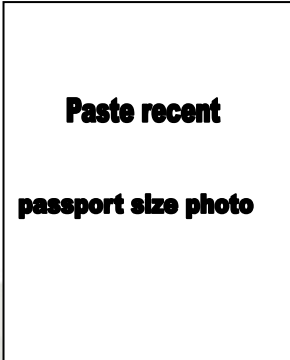

These Terms and Conditions apply to the participants of the Indian Premier Cricket League (IPCL™) Official League of Indian Twenty20 Cricket Federation®&© ITCF INDIA™ throughout the term of the Selections, Probable's including the Registration, Short-Listing, Training Camps as well as matches, trials, practice matches, fitness tests etc. conducted during the course of the selection, organised and owned by Indian Premier Corporate League (IPCL™) www.ipcl20.co.in

"Note"

It is necessary for all the participants come in IPCL™ through their concern T20 associations i.e. State/City/Distt./Zonal/Teshil/Club Twenty20 cricket units affiliated with: Indian Twenty20™ Cricket Federation®&© ITCF India™. (www.itcf20.com™)

1. Eligibility:

The eligibility criteria for participation in the Indian Premier Corporate league are as follows:

- a. The participant must be above 15 years of age as on 30-Sep-2010 and must carry proof of age to trials venue. At least one of the following documents is mandatory as proof of age:
 - i. Birth Certificate
 - ii. School Leaving Certificate
 - iii. Passport
 - iv. Ration Card
- b. The participant must have at least one of the following forms of photo-identification as proof of identity, and must carry it to the trials venue:
 - i. Passport
 - ii. School / college / T20 cricket association photo ID card/Form
 - iii. Bank photo-ID card
 - iv. Ration card if it contains photo-identification
 - v. Voters photo-ID card (if over 18 years of age)
 - vi. Driving license (if over 18 years of age)
 - vii. PAN card (if over 18 years of age)
- c. If the participant's age is between 15 and 18 years of age as on 30-Sep-2010, the participant's natural or legal guardian must certify their approval for participation by countersigning this form.
- d. The participant must be a citizen of India.
- e. The participant must not have any criminal record and should have no criminal proceedings currently pending against him in any court or tribunal, in India or world-wide.
- f. The participant must be of sound mind and health, and must not have any illness, disability or health condition that would expose either the participant, or any other participants or organizers of the event, to any health risk. The Participant will have to provide an undertaking to this effect as a prerequisite to participation in the Selections trails of the Indian Premier Corporate league IPCL™
- g. The Indian Premier Corporate league IPCL™ is open to both men & boys participants and IPCL™ encourages poor/rural participants to participate in the Indian Premier Corporate league IPCL™.



- h. Participation in the Selections trials will be entirely at the cost of the participant, and no outstation travel cost, accommodation cost, food or subsistence costs, or any other claims or reimbursements will be borne by the Indian Premier Corporate league IPCL™ its organizers, the television channels, sponsors or any other entities associated with the IPCL™
- c. The Indian Premier Corporate league IPCL™, its organizers, the television channels, sponsors or any other entities associated with the Indian Premier Corporate league IPCL™ will not be responsible for any permanent or temporary injuries, disabilities, accidents or health issues caused directly or indirectly suffered by a participant or a third party as a consequence of any act or omission by a participant during the Selection trials, the fitness training camps, as well as practice/matches etc . - d. IPCL™ retains the right to expel any participant violating the Terms and Conditions from the selection process at any stage of the Indian Premier Corporate league IPCL™
- e. The participant must confirm in writing their availability at the Training camp location they are selected for the entire duration of the Selection (estimated to be 14 days) for which the venue as well as the specific dates are intimated as part of the Selection notification.
- f. In case selected in the Final Selections phase, the participants must confirm in writing their availability at the location of the final training camp anywhere in India, for the entire duration of the Indian Premier Corporate league IPCL™ (estimated to be up to 7 weeks), with no constraints such as school or college classes, examinations, vacation plans, family events or travel plans.



- g. The participants for each venue of the trials shall be selected at the sole discretion of the esteemed selectors/Panel of selectors appointed by the Indian Premier Corporate league IPCL™ and their decision shall be final and binding on all participants subject to the approval of the IPCL™.

- c.
